**DRAFT PROGRAM**

In France, the legal framework governing the use of restraint in psychiatry has evolved quickly over the last few years. The July 2011 Law on hospitalization without consent and the current plan to maintain a national register for the use of restraint and seclusion demonstrate a political will to control the use of restraint in psychiatry. Several studies conducted by the Directorate-General for Health show that the use of coercion in psychiatry is unequal throughout the French territory: variations range from 1 to 10 between counties. Moreover, these studies show a gradual increase in the use of coercion in psychiatric practice. Preliminary results from the HO/SPDRE survey, conducted by the WHOCC Lille, and still ongoing, indicate that the severity of mental disorders does not seem to be linked to the use of involuntary hospitalization.

Faced with these facts, how should we react? As reflected in the WHO Quality Rights program, based on the International Convention on the Rights of Persons with Disabilities, changing the application of coercion implies not only changing practices but also adopting a new perspective in our daily practices. Several innovative European experiences have shown that such change is possible.

The WHOCC Lille for Research and Training in Mental Health and the French Ministry of Health and Social Affairs are organizing this European workshop on the use of coercion in psychiatry. The main objective of this meeting is to broaden French thinking thanks to European experiences, as well as to launch a broader reflection on the creation of a National Observatory of coercion in psychiatry. Several European contributors, each having provided significant innovations in this area, will share their thoughts and views on their practices.

This meeting is open to service users and carers, mental health professionals, primary care professionals, social services professionals, elected officials and representatives and to anyone interested in the use of coercion in psychiatry in France and in Europe.

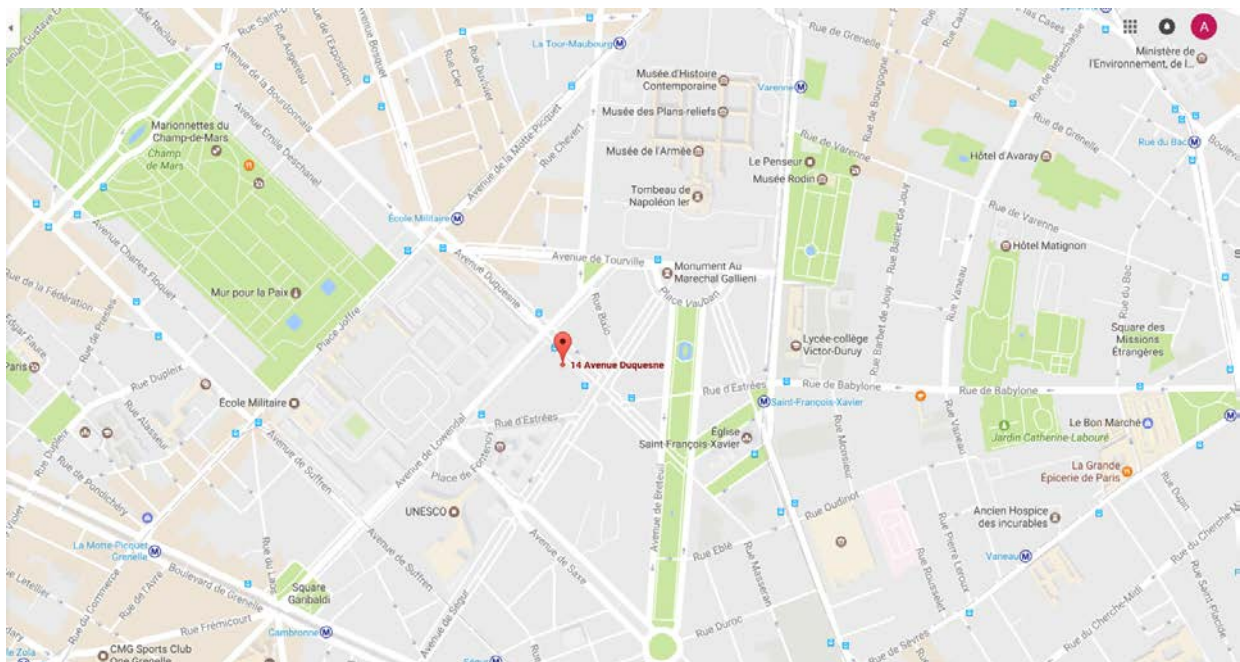
